

Lawrence Retirement Board Meeting Agenda

An application for superannuation has been received from **George Napolitano**, a 65 year old Lawrence Public School custodian with 30 years and 1 month service. If approved Mr. Napolitano will receive an annual option C allowance in the amount of \$ 31,064.40. (Nov 30th 2018 retirement date)
